

2024 U.S. Contraceptive Eligibility Guidelines: What You Need to Know

Description

The U.S. Medical Eligibility Criteria for Contraceptive Use, 2024 provides recommendations for safe contraceptive use, removing barriers to access. It is based on global guidance from the World Health Organization and adapted for the United States. The guidelines aim to support health care providers in offering comprehensive contraceptive services in a noncoercive manner, respecting individual values and autonomy. This report includes new and revised recommendations, including guidance for persons with chronic kidney disease and additional contraceptive methods. It emphasizes equitable access to contraception for all individuals. The document also addresses the importance of patient-centered contraceptive counseling to help individuals make informed decisions about their reproductive health.
