



Accusers of Sean 'Diddy Combs' may soon testify before a federal grand jury

Description

Federal investigators are preparing to bring accusers of music mogul Sean "Diddy" Combs before a federal grand jury, indicating that the US Justice Department is moving towards potentially seeking an indictment of Combs. Possible witnesses have been informed by investigators that they may testify in front of a grand jury in New York City.
