



Analyst makes 'Bitcoin's price to 10x post halving' prediction because...

financial **place** and potential **bankruptcy** fears. Genesis shifted its investment to Bitcoin to fortify its financial standing.

Genesis traded approximately 36 million shares of GBTC to raise funds for purchasing more Bitcoin, aiming to **capitalize** on its surging prices. The funds will also be used to pay **debt** owed to creditors. A social media **enthusiast**, Crypto Patel, applauded Genesis's drastic step, pointing out that the firm converted GBTC shares into 32,041 BTC (valued at \$2.1 billion) over three weeks.

The transactions led to extreme **volatility** in GBTC share prices, significantly influenced by shifts in Bitcoin prices. Following these maneuvers, Bitcoin was trading at \$67,882.72 at the time of writing, marking a 1.28% increase in the past 24 hours.

As Bitcoin navigates a consolidation phase, **uncertainty** hovers over its future direction. However, the prospect of Bitcoin's fourth halving has led to increased BTC accumulation by major investors. These moves hint at a **bullish** outlook considering the supply dynamics.

Crypto-analysis firm, QCP Capital, observed a recent surge in optimism surrounding BTC and noted an increase in BTC spot ETF inflows. They also highlighted that the **substantial** Bitcoin call buying, together with decreased leverage and cautious trader approach, contributes to market stability.

Despite the current scene, investment professional Anthony Scaramucci remains optimistic about Bitcoin's future. He predicts a substantial increase in Bitcoin prices post-halving, believing it could surge six to ten times. However, he emphasized that these gains might not be immediate but could unfold gradually over time.
