



D4vd Charged Over Celeste Rivas Hernandez's Killing

Description

Seven months after the body of 14-year-old Celeste Rivas Hernandez was discovered in d4vd's car, prosecutors in Los Angeles have charged the singer with first-degree murder, mutilation of human remains, and sexually abusing a child.

Many reporters have questioned why it took so long for the charges to be filed. Since the body was found, state authorities have held a grand jury meeting, interviewed d4vd's family and friends, and kept investigation details private. Throughout this time, investigators faced criticism for not making an arrest sooner, despite national attention on the case.

d4vd, who has pleaded not guilty, will have his lawyers defend him, claiming he did not kill Celeste. Following the criticisms of the lengthy investigation, Los Angeles Police Chief Jim McDonnell stated that the aim was to ensure justice, which often requires patience.

Analysts suggest several factors prolonged the investigation, such as the condition of the evidence, the sensitive nature of the charges involving a minor, and difficulties in gathering witness statements. Former federal prosecutor Neama Rahmani expressed that the case has created tension in LA, noting that the police's handling of it has raised public concern.

The case is complex, and prosecutors must carefully build their arguments as they prepare for court.
