

DA Argues Menendez Brothers Shouldn't Serve Life in Prison

Description

Los Angeles County District Attorney George Gascón posits that the Menendez brothers ought not to languish in penitentiary confines for the remainder of their lives.

"Considering the entirety of the circumstances, I contend that they do not merit perpetual incarceration," Gascón articulated during an interview with co-anchor Juju Chang, featured in an episode of *IMPACT x*Nightline entitled "Menendez Brothers: Monsters or Victims?"

The forthcoming episode, set to debut on Hulu on Thursday, October 17, revisits the notorious case of Lyle and Erik Menendez, who were found guilty of patricide and remain imprisoned in California. It incorporates appeals for their exoneration from friends and relatives, alongside interviews with notable figures such as their cousin Karen VanderMolen-Copley, comedian Rosie O'Donnell, and defense attorney Mark Geragos.

This episode emerges in the wake of Gascón's announcement, mere weeks prior, regarding his office's readiness to reconsider the Menendez brothers' petition for resentencing, a development that could potentially facilitate their release.

"My inclinations are not fixed at this juncture," Gascón remarked. "We have seasoned legal professionals meticulously assessing this case. Their recommendations will subsequently be presented to me, yet the ultimate determination rests with me."

While Gascón has the authority to advocate for resentencing, the adjudication rests ultimately with a presiding judge.

In 1996, Lyle and Erik Menendez were adjudicated guilty of murder in the first degree for the deaths of their parents, Jose and Kitty Menendez.

In May 2023, the brothers' legal representatives filed a habeas corpus petition with the Los Angeles County Superior Court, presenting newly-acquired evidence pertinent to their case.

The evidence encompasses allegations of sexual abuse leveled by Roy Rosselló, a former member of the Puerto Rican boy band Menudo, against Jose, who he claims perpetrated acts of rape against him in the 1980s, in addition to a recently uncovered letter authored by Erik to his late cousin Andy Cano, wherein he delineates his father's alleged sexual abuses occurring months preceding the murders.

Gascón articulated during the aforementioned press conference that his office bears a "moral and ethical responsibility to scrutinize the information presented" to ascertain whether a resentencing is warranted or if a new hearing is appropriate. Gascón further emphasized, "Should evidence which was previously unconsidered come to light, it is plausible that a jury's verdict could have differed."

On August 20, 1989, Lyle, aged 21, and Erik, aged 18, executed the fatal shootings of their parents in the den of their Beverly Hills residence using 12-gauge shotguns.

Jose, then the chief operating officer of RCA Records, was shot multiple times, including a point-blank shot to the head, while Kitty, aged 47, was shot 15 times, with one shot striking her in the face.

According to the brothers, the killings were precipitated by years of sexual abuse inflicted by Jose, which they assert their mother, a former beauty queen, willfully ignored.

In contradistinction, prosecutors at the time contended that greed was the brothers' principal motive, evidenced by their extravagant expenditures immediately following the murders.

Ultimately, in 1996, three years subsequent to a hung jury outcome in their initial trial, the siblings were found culpable of first-degree murder and sentenced to life imprisonment without the prospect of parole.

Mark Geragos, the Menendez brothers' attorney for post-conviction matters, stated, "Anyone engaging with the facts and circumstances rationally will inevitably arrive at the conclusion that their continued incarceration is unwarranted."

He further asserted, "They have served their time."
