



Diddy's Mom Stands By Him Amid Sex Crime Charges

Janice Combs, the mother of Sean "Diddy" Combs, articulated her devastation on Sunday in response to the grave allegations against her son, expressing profound sorrow in a statement to Fox News Digital.

On September 16, Diddy was detained and subsequently charged with racketeering conspiracy, sex trafficking through force, fraud, or coercion; and facilitating transportation for prostitution. He entered a not-guilty plea shortly after an indictment outlining his purported sexual crimes was made public. Should he be convicted, he faces a minimum sentence of 15 years, with the potential for life imprisonment.

"It is genuinely heartbreaking to witness my son being judged not by truth, but rather by a narrative constructed from falsehoods," Janice Combs articulated. "To bear witness to what resembles a public vilification of my son before he has had the chance to defend his innocence is an unbearable anguish. Like any individual, my son is entitled to his day in court to present his perspective and demonstrate his innocence."

She implored, "My son is far removed from the monstrous caricature they have conjured; he merits the opportunity to voice his truth. I can only hope to witness him vindicated."

"I do not seek to present my son as flawless, for he is not," Janice Combs declared. "He has committed transgressions in his past, as we all have. While he may not have entirely disclosed certain truths, such as denying violent behavior towards an ex-girlfriend in light of video surveillance evidence, it is essential to recognize the complexity of truth."

She remarked, "At times, truth and deception intertwine so closely that acknowledging even a segment of the narrative becomes daunting, particularly when that truth challenges societal norms or is difficult to comprehend. This prevailing confusion explains, in part, why my son's legal counsel opted for a settlement with the ex-girlfriend rather than contesting the matter vigorously, inadvertently allowing the federal government to interpret this action as an admission of culpability."

Surveillance footage from a Los Angeles hotel in 2016 purportedly captured Diddy perpetrating violence against his then-girlfriend, Cassie Ventura. The indictment outlined how he "kicked, dragged, and hurled a vase at a woman attempting to depart," and when hotel security intervened, he allegedly sought to bribe the personnel to secure their silence.

"It is vital to understand that none of us, regardless of our societal status, are immune to fear or fallibility," Janice Combs asserted. "The failure to be fully forthcoming regarding one matter should not equate to guilt concerning the reprehensible accusations and severe charges thrust upon him. Numerous individuals who have been wrongly convicted and subsequently exonerated had their freedoms stripped not due to culpability, but owing to a failure to conform to societal standards of 'good character.' History has demonstrated how individuals can be unjustly convicted based solely on past conduct."

She added, "Witnessing the public revel in my son's misfortune is an indelible trauma. It is excruciating to observe the populace turning against him based on fabrications and misconceptions, without granting him the opportunity to present his narrative."

Janice Combs suggested that certain individuals were motivated by "financial gain" in their deceitful narratives about her son rather than a quest for justice. "These individuals perceived the expediency with which my son's legal team settled the ex-girlfriend's lawsuit as an opportunity for a swift payout through false accusations," she stated. "Such unfounded allegations of sexual assault severely hinder genuine victims of sexual violence from achieving the justice they rightfully deserve."

Janice Combs leveled accusations against the federal government for employing similar tactics in their prosecution of her son, asserting that the ensuing injustice has been "insufferable" for their family.

"The most distressing aspect of this situation is witnessing my cherished son stripped of his dignity, not for



his actual conduct but rather for what society chooses to believe about him," she stated, further urging his supporters not to "render their judgment before they have officially heard his account."

"I implore you to consider those who have been wrongfully persecuted and to recognize that not every individual who has faltered in life should be subjected to a lifelong verdict based on a singular incident or a series of missteps," she continued.

Authorities have alleged that Diddy operated a criminal enterprise through various business entities, including Bad Boy Entertainment, Combs Enterprises, and Combs Global, among others. He purportedly utilized "firearms, threats of violence, coercion, as well as verbal, emotional, physical, and sexual abuse" to fulfill his illicit desires, according to the unsealed indictment obtained by Fox News Digital.

Diddy and his associates allegedly used coercion, threats, and deception to lure women into his sphere, often under the facade of romantic entanglement. Subsequently, Combs allegedly employed force and intimidation to compel these women to engage in prolonged sexual acts with male sex workers, referred to as "freak offs."
