

Elon Musk Calls Trump Adviser Navarro a 'Moron' Over Tesla Remarks

Description

Elon Musk recently criticized President Donald Trump's trade adviser, Peter Navarro, labeling him a "moron" due to comments Navarro made regarding Musk's electric vehicle company, Tesla. Musk, who also holds a position in the Trump administration, described Navarro as "dumber than a sack of bricks" in posts on his social media platform, X.

This exchange stemmed from an interview in which Navarro dismissed Musk's role in manufacturing, stating, "He's not a car manufacturer. He's a car assembler in many cases." During this interview, Navarro expressed a desire to see more automotive parts produced in the United States, aligning with Trump's tariff policies aimed at revitalizing American manufacturing.

Musk countered Navarro's assertions, claiming they were "demonstrably false," and highlighted that Tesla is the most vertically integrated auto manufacturer in America, with the highest percentage of parts made in the U.S. He backed his argument with a 2023 article from Kelley Blue Book, citing Cars.com, which affirmed Tesla's commitment to U.S. manufacturing.

Technology analyst Dan Ives noted that while Tesla is somewhat insulated from tariffs compared to traditional automakers like GM and Ford, they still source many parts from abroad, particularly from China. He warned that existing tariffs could disrupt Tesla's supply chain and impact its competitive edge.

This public disagreement illustrates a significant rift between Musk and Trump's trade team, as Musk has frequently hinted at discontent with the administration's trade policies. Other supporters of Trump have echoed concerns about the economic effects of tariffs, signaling a broader discontent among American business leaders regarding current trade strategies.
