# Kanye West Loses Talent Agency; Shopify Closes Yeezy Site

## Description

## Topline

Kanye West's talent agency has severed ties with him following his online posting spree filled with antisemitic messages and the sale of swastika-emblazoned T-shirts through his fashion brand. This resulted in Shopify shutting down his website, and he is also facing a lawsuit from a Jewish former employee who claims he texted her, "Hail Hitler."

## Timeline

Feb. 11 The Yeezy website displayed an all-white screen stating, "Something went wrong. What happened? This store is unavailable."

Shopify informed [multiple news outlets](#) that it was responsible for taking down the site due to West's non-compliance with commerce standards.

Uncertainty surrounds whether any of the swastika T-shirts were shipped to buyers during the brief period they were available.

Feb. 11 A Jewish former employee filed a lawsuit in California, alleging discrimination and harassment by West based on her religion and gender.

The plaintiff, who worked for Yeezy in 2024, reported instances of antisemitic remarks, including a text message stating, "Welcome to the first day of working for Hitler," alongside inappropriate content.

Feb. 10 33&West, a Los Angeles talent agency, announced it would no longer represent West, with his agent, [Daniel McCartney](#), specifically citing West's "harmful" rhetoric.
