

## NAACP Exposes Companies That Neglect DEI in Spending Guide

### **Description**

The NAACP is encouraging Black Americans to support companies that continue to promote diversity, equity, and inclusion. They have provided a list of brands that have either upheld or abandoned their commitment to DEI programs. The NAACP believes that DEI initiatives are vital for the progress of Black Americans, who are projected to spend a significant amount on goods and services by 2030.
