

Today's live stock market updates: Stay informed!

Description

Amid morning trading on February 23, 2024, traders bustled on the floor of the New York Stock Exchange in New York City.

The market scene was a buzz with activity as optimism spread throughout Wall Street following the recent three-day losing streak.

The S&P 500 futures surged by 0.6%, while Nasdaq 100 futures climbed 0.9%. In a similar vein, Dow Jones Industrial Average futures brought a 215-point gain, marking a solid rise of about 0.55%.

However, the after-hours trading session presented a different picture, with Super Micro Computer witnessing a hefty 13% drop due to underwhelming fiscal fourth-quarter earnings. Airbnb faced a similar fate, sliding by 16% post-releasing disappointing second-quarter results.

The market landscape on Tuesday saw a reversal of fortunes. The S&P 500 and Nasdaq Composite each saw a 1% upswing, while the Dow added nearly 300 points. This resurgence offered a glimmer of hope after Monday's somber performance, driven by recession fears and the unraveling of the yen carry trade.

Despite this bounce, uncertainty lingers, according to LPL Financial's Quincy Krosby. The road ahead may still be tumultuous, with August and September likely to bring continual volatility.

Looking ahead, the earnings season is anticipated to inject some positivity into the market, particularly with upcoming reports from Disney, CVS Health, Shopify, and Novo Nordisk.
