



# UK Prohibits EU Cheese and Meat Imports over Foot and Mouth Concerns

## Description

The UK government has temporarily banned holidaymakers from bringing cheese and meat products from the EU to prevent the spread of foot and mouth disease (FMD).

This ban includes cured meat and cheese, even in sandwiches, due to the outbreak in Europe.

The restrictions apply to all packaged goods, duty-free purchases, and regardless of origin.

Previous bans on these products from specific European countries have been extended to all EU countries.

Foot and mouth disease is a highly contagious virus affecting animals but not humans.

Partial cooking or smoking of meat products and improper pasteurization of dairy products can allow the virus to survive.

The ban does not apply to Northern Ireland, Jersey, Guernsey, or the Isle of Man.

Violators may face fines or product confiscation.
