

## Watchdog Approves Vodafone-Three Merger: Green Light Expected

### **Description**

The government's organization that checks on competition in the UK mobile market says Vodafone and Three can join together if they promise to keep prices fair and improve 5G. Before, the organization was worried that combining the two companies could raise prices and stop competition. But now, they think the concerns can be fixed if the companies agree to their ideas. Vodafone thinks the proposal is good and will help the deal go through.

Vodafone and Three want to combine their businesses in the UK. They would have around 27 million customers together. The organization checking on competition thinks the deal could be good for the mobile industry if they make sure prices stay okay. They also want to make sure other smaller mobile companies can still offer good deals.

People in the mobile industry believe that this deal could make the market more competitive, which is good for everyone. They have until November 12th to respond to the proposals, and a decision will be made by December 7th.
