



# Who's Eyeing Ubisoft? Potential Buyers for Assassin's Creed

## Description

Ubisoft, the renowned French gaming publisher, is currently under scrutiny as it faces delays with its latest Assassin's Creed game and is exploring strategic options, raising speculation about a potential sale.
