



WWE Royal Rumble 2025: Live Results, Highlights, and Analysis

Description

The evening commenced with the highly anticipated eighth installment of the women's Royal Rumble match in WWE history. Stephanie McMahon was introduced to the audience and received an enthusiastic reception from the crowd in Indianapolis. She highlighted several notable streaming successes that WWE has achieved this year, expressed gratitude to the fans, and ignited the celebration with a dramatic pyro display to officially commence the event.

Subsequently, a video montage narrated by former Colts punter and media personality Pat McAfee set the tone for the match. The contest began in earnest with Iyo Sky, who entered at No. 1 for her third Royal Rumble appearance, facing off against Liv Morgan, a formidable presence in WWE's women's division and a consistent participant in every Royal Rumble, having previously secured second place in consecutive years.

Chelsea Green followed at No. 5, and as the ring filled with more entrants—B-Fab at No. 6 and Ivy Nile at No. 7—no eliminations had yet occurred.

As the match progressed, Ivy Nile eliminated Lyra Valkyria, hinting at future conflicts over the Women's Intercontinental Championship. The iconic Bayley entered at No. 12, eager to become the first two-time winner of the women's Royal Rumble. With the inclusion of notable wrestlers like Sonya Deville at No. 13 and Naomi at No. 15, the pandemonium intensified.

The climax saw Charlotte Flair return at No. 27, showcasing remarkable prowess by eliminating several opponents, ultimately leading to her victory and making her a two-time Royal Rumble champion, while Roxanne Perez set a new record for time spent in a single match.

Charlotte Flair clinched the Women's Royal Rumble victory in a dramatic finale lasting one hour and ten minutes.
